Directions: Take I-5 towards Sacramento. Take 113 north towards Woodland. Take the first exit (Hutchison Drive) and bear right (east) on Hutchison Drive. Turn right at the first stop light (LaRue Road). Follow LaRue Road to the first right turn (Garrod Drive). Follow Garrod Drive to the stop sign. After stopping, proceed directly ahead. The client parking lot entrance is on your right. Client parking is free as long as you park in a designated patient parking space. Client parking cannot accommodate vehicles that require more space than a passenger car. There are three different reception stations and it is important to come to the station mentioned when you made your appointment. Reception station 3 is in the building on your left as you drive toward the parking lot and reception stations 1 and 2 are in the main hospital building which is to the west of the parking lot. Novice B&A and Excellent B&A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Novice and Open – all heights will walk the course together prior to their class being judged. The Excellent class may be split by height at the discretion of the judge and show committee.

Judging will begin each day at 8:00 am. Check in will begin at 7:00 am. All dogs must either: be measured or present a height card at check in, or have previously sent a copy of their height card to the Trial Secretary. Measurement of dogs without height cards will be at approximately 7:30 am each day.

Class will be judged in the following order:

Saturday – Tall to Small 177 Dogs – 436 Runs

Standard Ring – Open, Excellent, Novice, Open FAST, Novice FAST

JWW Ring – Excellent, Open, Novice, Excellent FAST

Sunday – Novice and Open - Small to Tall 172 Dogs – 426 Runs

Standard Ring – Novice FAST, Open FAST, Excellent 24, 26, 4, 8, 12, 16, 20, Open, Novice

JWW Ring – Excellent FAST, Excellent 16, 20, 24, 26, 4, 8, 12, Open, Novice
