Dixon May Fairgrounds – Outdoors on grass
655 South First St., Dixon, CA 95620

General Set up Time is 3 pm. The show committee plans to use: areas on both the North and South Lawns, from half way down Dixon Blvd to Vacaville Way and the first 6 RV campsites on Vacaville Way. Daily parking inside the fairgrounds close to the rings is by permit only. Vehicles with permits may NOT park in front of the Grandstand – this is a fire lane. **All other vehicles must park in the regular parking lot – behind the red fence and fence line.** You may drive in to unload but all cars must be moved to the regular parking lot by 7:30 am each day.

Preliminary running order contingent on move-up entries not yet received. Exhibitors shall be provided armbands or stickers indicating their dog's running order number for this trial. **Per AKC rules, the move up deadline is 6 pm Monday, September 3, 2007.** Absolutely no move ups for Saturday will be allowed after this time and date. Move ups for Sunday must be given to the Trial Secretary, at the show site, in writing within 15 minutes of the last dog completing the course.

Excellent B&A and Novice B&A Standard and JWW classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through: will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Novice and Open – all heights will walk the course together prior to their class being judged. The Excellent class may be split by height at the discretion of the judge and show committee.

Dixon May Fairgrounds

The rings will be outdoors on grass and measure 100' x 120'. Bring cover for sun and rain. The area on the North lawn bordering Dixon Blvd. to Vacaville Way, and the first six campsites on Vacaville Way are reserved for the show committee. Anyone other than those designated by the trial secretary and show committee who set up or attempt to camp in this area will be moved. No parking is allowed on Dixon Blvd. Saturday and Sunday morning you may drive in to unload. All vehicles must be moved to the regular parking lot, behind the red fence or across the street, by 7:30 am. **Absolutely no vehicles may drive in to load or unload either day while the rings are running.** RVs may exit out the back gate. Food and beverages will be available for purchase from Dannie's catering.

Directions:

From I-80 west in Dixon:

Take 113 South towards Dixon.

From I-80 east, take the Dixon Ave/A Street exit and go right on A Street. Turn right on First Street. The fairgrounds are 3 blocks south on your left side. Go past the office/main entrance drive and turn left into the south end of the fairgrounds.

Judging Schedule

Judging will begin each day at 8:00 am. Check in will begin at 7:00 am. All dogs, regardless of jump height must either: be measured or present a height card at check-in, or have previously sent copy of the height card

to the Trial Secretary. Measurement of dogs without height cards will be at approximately 7:30 am each day and in between classes as time allows.

Saturday: Sharon Kihara will judge all Standard Classes. Renee Fitch will judge all JWW classes. The jump height will be tall to small.

Sunday: Sharon Kihara will judge all JWW Classes. Renee Fitch will judge all Standard classes. The jump height will be small to tall.

Class order will be as follows both days:

Standard Ring: Excellent, Open, Novice

JWW Ring: Open, Novice, Excellent
