**Awards**

Flat ribbons will be awarded 1<sup>st</sup> – 4<sup>th</sup> place in each jump height class to dogs earning a qualifying score. Prizes will be awarded to 1<sup>st</sup> place in each jump height class to dogs earning a qualifying score. Green ribbons will be awarded to all dogs earning a qualifying score. Double Q pins will be awarded to Excellent B dogs who qualify in Standard and JWW on the same day. MACH ribbons and MACH jump bar will be awarded to any dog earning the MACH title.

**Course Familiarization/Warm-ups**

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in that class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

**Running Order and Schedule**

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. The times listed are when judging will begin. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately **7:30 am**. Novice and Open all heights will walk at the same time. Excellent may be split by height at the discretion of the judges and show committee.

Judging will begin each day at 8:00 am. Check in will begin at 7:00 am.

Height Cards: all dogs jumping lower than 24" must either be measured; present a card at check in or have previously sent a copy of their height card to the Trial Secretary. Measurement of dogs without height cards will be at approximately 7:30 am each day and in between classes as time allows.

**Dogs will be judged as follows:** from the lowest number in each class to the highest number.

The jump height on Saturday will be tall to small for all classes.

The jump height on Sunday will be: 16, 24, 26, 4, 8, 12, 20 for all classes except FAST which will run small to tall.

The jump height on Monday will be: small to tall.

**Classes will run in the following order all three days:**

**Standard Ring:**

Sat: Ex, Ex FAST, Open, Nov

**JWW Ring:**

Open FAST, Novice FAST, Novice, Open, Ex

Dan Butcher will judge all Excellent level classes. Laura Finco will judge all Novice & Open level classes.

**Class Information, Jump Heights, Scoring**

**Classes offered:** Regular Titling: Novice A & B, Open, Excellent & B for Standard, JWW and FAST. Preferred: Novice, Open, Excellent A & B for Standard, JWW and FAST. Owners are responsible for entering the proper class and height. Complete rules can be found on the AKC website at [www.akc.org](http://www.akc.org). Minimum order is \$10.00. Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

**Notice to Exhibitors**

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline rules for the listing of registrable breeds that may participate.

Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.

If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Tuesday and Friday.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

**EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE EENTRIES CANNOT BE ENTERED IN THE TRIAL.**

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors, while competing must wear proper footwear. Exhibitors will not be allowed to compete in "bare" feet or open toe shoes.

No smoking in buildings or arena.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
