Prizes and Awards

Ribbons will be awarded 1st—4th place in each jump height class to dogs earning a qualifying score. Dog toys will be awarded to 1st place in each jump height class to dogs earning a qualifying score. Green Ribbons will be awarded to all dogs earning a qualifying score. Green Rosettes will be awarded to Excellent B dogs qualifying in Standard and JWW on the same day.

Judging Schedule

Novice and Excellent B&A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through: will begin as soon as the Judge has approved the course. This will be at approximately 8:30 am. Novice and Open – all heights will walk the course together prior to their class being judged. The Excellent class may be split by height at the discretion of the judge and show committee.

Laura Finco will judge all Novice and Open level classes. Cindy Macklin will judge all Excellent level classes.

Judging will begin each day at 9:00 am. Check in will begin at 8:00 am

Dogs that do not have an AKC height card must either: be measured or present a height card or measure receipt at check-in. Measurement of dogs without height cards will be at approximately 8:30 am each day and in between the excellent class as time allows.

Dogs will be judged as follows: from the lowest number in each class to the highest number.

Junior Handler Agility Competition

The Junior handler will run at the end of the class. There is one junior handler, entered in Excellent B Standard and Excellent B JWW, 24".

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in the class. A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

50% refund for bitches in season after the closing date and up to the Thursday before the event.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. The State of California requires Rabies vaccine.
