**General Exhibitor set up time is 3 pm. Absolutely no exhibitor set ups, x-pens, crates, chairs etc. are allowed before this time.**

Do not, under any circumstances, allow or encourage your dog to relieve itself anywhere under, in or on the arena floor, structure, or anything manmade anywhere on the site. Think about it: your dog relieves itself on a metal fence post; the next male dog that comes along has to mark on top of your dog, now the paint is corroded and someone has to repaint the fence post to keep it from rusting. Additionally, be sure to pick up after your dogs regardless of where or when they leave a mess. At recent shows, we have all picked up many, many piles of dog droppings. We don't know that they are from agility competitors, but we will be blamed, regardless of who leaves them. Disregard of this directive will be cause for a Bench Committee hearing.

This is a preliminary judging schedule which is contingent on move-up entries not yet received. Exhibitors shall be provided armbands or stickers indicating their dog's running order number for this trial. **Per AKC rules, the move up deadline is 6 pm on Monday, January 14, 2008.** Absolutely no move ups for Saturday will be allowed after this time and date. Move ups for Sunday must be given to the Trial Secretary, at the show site, in writing within 15 minutes of the last dog completing the course on Saturday.

**Sonoma County Fairgrounds – Lyttle Cow Palace**

The trial will be held under cover on dirt at the Sonoma County Fairgrounds and will measure approximately 100 x 90. There is limited space under cover for crating. Please conserve space so all dogs can fit under cover. Food and beverages will be available for purchase on site.

**Directions:**

Take highway 101 to Santa Rosa. Exit onto highway 12 eastbound towards Sonoma. Exit highway 12 at the South E Street/Downtown exit. Upon reaching the surface street, Bennett Valley Rd., you will come to a stoplight and just in front of you on your right will be the Sonoma County Fairgrounds. If you are coming by highway 12 westbound, take the Downtown exit and turn left at the stoplight. This will lead you to the entrance to the fairgrounds. We are working with the fairgrounds for onsite parking. An email will be sent closer to the show with final parking instructions.

## **Judging Schedule**

Judging will begin each day at 8:00 am. Check in will begin at 7:00 am. All dogs must either: be measured, or present a height card at check-in, or have previously sent a copy of the height card to the Trial Secretary. Measurement of dogs without height cards will be at approximately 7:30 am each day.

Dogs will be judged as follows: from the lowest number in each class to the highest number.

The jump height on Saturday will be: 26, 24, 20, 16, 12, 8, 4

The jump height on Sunday will be: 4, 8, 12, 16, 20, 24, 26.

Novice B/A Standard, JWW and FAST classes and Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors. Judging will begin each day at 8:00 am.

Walk through: will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Excellent Standard and JWW walk through will be split at the discretion of the judges and show committee. All heights for all other classes will walk the course together prior to their class being judged.

Check In at the Gate: Only the Gate Steward or Score Table personnel may change the running order.

**Handlers may not move their own dogs.** Handlers with multiple dogs will be separated by at least 10 dogs if at all possible, given the number of dogs in their jump height. If there are not 10 dogs between a handler's dogs then moves will be handled on a case by case basis. The first dog running will be moved up in the running order to the maximum extent, then and only then, will the second dog be moved down until there are 10 dogs between them.
