**Prizes and Awards**

Rosettes will be awarded 1st—4th place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. Double Q rosettes will be awarded to Excellent B dogs earning a Double Q.

Will you MACH at this event? Please let the trial secretary know if there is a chance you will MACH at this event. The GGPWCF would like to present you with a special rosette and jump bar to commemorate your MACH title.

**Judging Schedule**

Novice B&A and Excellent B&A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

**Walk through** will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Novice and Open – all heights will walk the course together prior to their class being judged. The Excellent class may be split by height at the discretion of the judge and show committee.

**Judging will begin each day at 8:00 am. Check in will begin at 7:00 am.** Before their first run of the weekend, ALL dogs must either: be measured or present a height card at check in, or have sent a copy of their height card to the Trial Secretary. Measurement of dogs without height cards will take place near the score table at approximately 7:30 am each day. Cindy Macklin will measure dogs for height cards.

Class will be judged in the following order:

**Saturday – 159 Dogs – 384 Runs**

**Height order as follows:** Tall to Small for Standard and JWW. FAST will run Small to Tall  
Standard Ring – Open, Excellent, Novice, Novice FAST  
JWW Ring – Excellent, Open, Novice, Excellent FAST, Open FAST

**Sunday – 154 Dogs – 371 Runs**

**Height order as follows:** Small to Tall for Standard and JWW. FAST will run Tall to Small  
Standard Ring – Open, Excellent, Novice, Novice FAST  
JWW Ring – Excellent FAST, Open FAST, Excellent Open, Novice

### **Course Familiarization/Warm-ups**

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in the class. A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

### **Move Ups**

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing within 15 minutes of the last dog completing the course.

### **Notice to Exhibitors**

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
