Prizes and Awards

Rosettes will be awarded 1st – 4th place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. Rosettes will be awarded to Ex B Std/JWW dogs earning a Double Q. Dogs earning a title will receive a Title Ribbon. Dog related items will be awarded to 1st place in each class to dogs with qualifying scores.

Class Information, Height Division, Obstacles, Scoring

Classes offered: Regular Titling: Novice A & B, Open, Excellent A & B for Standard and JWW. Preferred: Novice, Open, Excellent A & B for both Standard and JWW.

Owners are responsible for entering the proper class. Complete rules can be found on the AKC website at www.akc.org. For a copy of the rulebook write to: American Kennel Club, 5580 Centerview Dr., Raleigh, NC 27606-3390. To place a credit card order by telephone call: 919-233-6767 voice and 919-816-3627 fax. Minimum order is \$10.

Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing within 15 minutes of the last dog completing the course.

Preliminary running order contingent on move-up entries not yet received. Exhibitors shall be provided armbands or stickers indicating their dog's running order number for this trial. Per AKC rules, the move up deadline is 6 pm on Monday, August 4, 2008. Absolutely no move ups for Friday will be allowed after this time and date. Move ups for Saturday and Sunday must be given to the Trial Secretary, at the show site, in writing within 15 minutes of the last dog completing the course.

Judging Schedule

Check in will begin at 1:00 pm on Friday and 7:00 am on Saturday and Sunday. Armbands may be picked up at the score table each morning.

Judging will begin on Friday at 2:00 pm and on Saturday and Sunday at 8:00 am.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 1:30 pm on Friday and 7:30 am on Saturday and Sunday. Open and Novice, all heights will walk the course together prior to their class being judged. Excellent Standard and JWW will be split into four groups as follows:

4/8/12, 16, 20, 24/26

Excellent FAST will be split in two groups as follows: 4/8/12/16 and 20/24/26.

All dogs, regardless of jump height must either: present a height card at check, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

Measurement of dogs without height cards will take place near the score table at approximately 1:30 pm on Friday and 7:30 am on Saturday and Sunday. Judge Tammy Domico will measure dogs for cards.

Dogs will be judged from the lowest armband number in each class to the highest armband number in each class.

Friday judging will rotate between the Standard and JWW rings in four groups beginning with the first group in the Standard ring. Exhibitors are expected to walk in one ring while judging takes place in the other ring.

Standard: 20, 24/26, 4/8/12, 16

JWW: 4/8/12, 16, 20, 24

Class Order

Standard Ring—both days

Open, Excellent, Novice, Novice FAST

JWW Ring

Saturday—Excellent, Open, Novice JWW followed by Excellent FAST, Open FAST

Sunday—Excellent FAST, Open FAST followed by Excellent, Open, Novice JWW

Height Order

Saturday—26, 24, 20, 16, 12, 8, 4

Sunday—4, 8, 12, 16, 20, 24, 26

Ring Size and Surface

The trial will be held outdoors on grass. Ring size will be 100 x 120.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP / PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials.

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.
