The Fun Runs are open to all dogs regardless of their heritage. There will be one Standard and one JWW ring with courses nested in each. You may run the full course or any part of the course and remain in the ring for 65 seconds.

Pre Entry fee: \$5/run

Day of Event fee: \$10/run.

Each dog limited to a maximum of 4 runs

Match Total runs limited to 150. Each run will be limited to a maximum of 65 seconds.

Pre -entries close on July 21, 2008. No refunds for bitches in season.

# Dog Star Agility

## Fun Run :

- Dogs must be a minimum of 15 months of age to participate.
- Dogs must be able to perform all obstacles off leash.
- Dogs must be under control both in and out of the ring.
- No harsh corrections will be allowed.
- Treats and toys will be allowed in the ring.

The rings will be outdoors on dirt and measure 100' x 100'. Take exit 48 off I-5 and turn toward the City of Rogue River. This will be a right turn for those traveling North on I-5 and a left turn for those traveling South on I-5. Proceed over the railroad tracks and turn left onto Pine. Follow Pine out of town towards the town of Wimer for approximately 6 miles. Turn left onto Minthorne Rd. Travel approximately .5 miles across the creek and past Pine Grove Rd. The address is 250 Minthorne. This will be the first drive on your right after crossing Pine Grove Rd..

The organizing committee may refuse entry for any reason. There will be no refunds for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from the event, regardless of the reason for dismissal. It is expressly understood that entrants alone are responsible for the behavior of their dogs, children, or guests. Any entrant whose dogs, children, or guests create unnecessary disturbances or engage in unsafe or disruptive behavior, may at the discretion of the organizing committee, be asked to remove the offending dogs, children, or guests from the event grounds. No refund of fees will be made in such a case. Judge and/or gate steward may excuse any entrant for any infractions with NO REFUNDS.

We will allow day of match entries only until the total of 150 runs is reached. If you decide to enter day of match, be advised that it may be filled before you get there, or may fill while you stand in line. Check-in will begin noon.

### Assumption of Risk

**1. The undersigned is voluntarily engaging in dog agility as a recreational activity with the knowledge of the risks of injury, death, and property damage that may result from participation in dog agility.

**2. Release of Liability** The undersigned releases Dog Star Agility, ABBA Dogs, Lorie Abbott, Lisa and/or Robert Michelon from all liability to the undersigned, the "undersigned" representatives, guardians, successors, assigns, heirs, and next of kin for all liability, claims, damage, or demands for personal injury, death, or property damage, to the undersigned or the undersigned's dog(s), arising from or related to this agreement. This release includes, without limitation, any personal injury, death, or property damage caused by the active or passive negligence of Dog Star Agility, ABBA Dogs, Lorie Abbott, Lisa and/or Robert Michelon. The undersigned bears sole responsibility for any loss.

**3. Knowing and Voluntary Execution** the undersigned acknowledges that he or she has carefully read this agreement, understands it contents, and understands that this agreement includes an assumption of risk of the Dog Star Agility, ABBA Dogs, Lorie Abbott Lisa and/or Robert Michelon negligence and a release of their liability. The undersigned acknowledges that Dog Star Agility, ABBA Dogs, Lorie Abbott, Lisa and/or Robert Michelon are materially relying on this waiver in allowing the undersigned to participate in this dog agility event.

**4. I also state my dog(s) is/are not aggressive towards people or other dogs** and that I understand I alone am responsible for the behavior of my dog(s), that any dog, which is out of control, creates an unnecessary disturbance or engages in unsafe or disruptive behavior, may at the discretion of the organizing committee, be expelled from the event grounds with NO REFUNDS.
