Awards

Ribbons will be awarded 1st—4th place in each jump height class to dog earning a qualifying score. Green ribbons will be awarded to all dogs with qualifying scores. QQ pins will be awarded to Excellent B dogs earning a Double Q. Dog toys valued at \$2-\$3 will be awarded to first place in each jump height class to dogs with qualifying scores. Free entry vouchers good for the 2009 event will be awarded to the high scoring dog in Novice, Open and Excellent each day. High scoring Flat Coat Retriever each day will receive a voucher good for one free day at the 2009 Specialty Agility Trial or the 2009 Flat Coated Retriever All Breed Agility Trial. Notify the Trial Secretary if you hope to finish a MACH at this event.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. No obstacle familiarization will be offered at this event. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Class Information, Jump Heights, Scoring

Classes offered: Regular Titling: Novice A & B, Open, Excellent & B for Standard and JWW. Preferred: Novice, Open, Excellent A & B for both Standard and JWW. Owners are responsible for entering the proper class and height. Complete rules can be found on the AKC website at www.akc.org. For a copy of the rule book write to: American Kennel Club, 5580 Centerview Dr., Raleigh, NC 27606-3390. To place a credit card order by telephone call: 919-233-9767 voice and 919-816-3627 fax. Minimum order is \$10.00. Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Open and Novice, all heights will walk the course together prior to their class being judged.

Excellent Standard and JWW will be split into four groups as follows:

4/8/12, 16, 20, 24/26

Excellent FAST will be split in two groups as follows: 4/8/12/16, 20/24/26.

Judging will begin each day at 8:00 am.

Check in will begin at 7:00 am. Armbands may be picked up at the score table each morning.

Dogs will be judged as follows: from the lowest number in each class to the highest number.

Class Run Order:

Standard Ring—each day

Open, Excellent, Novice, Novice FAST

JWW Ring—

Friday & Monday

Excellent, Open, Novice, FAST Excellent, Open

JWW Ring—

Saturday & Sunday

FAST, Excellent, Open

JWW Excellent, Open, Novice

All dogs, regardless of jump height must either: present a height card at check in, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

Measurement of dogs without height cards will take place near the score table. Kathie Leggett will measure dogs for 10 minutes at the top of each hour unless the Excellent B 12" course walking or competing in which case come back at the next hour.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP or PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline rules for the listing of registrable breeds that may participate.

Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.

If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Tuesday and Friday.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors, while competing must wear proper footwear. Exhibitors will not be allowed to compete in "bare" feet or open toe shoes.

No smoking in buildings or arena.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
