Preliminary running order contingent on move-up entries not yet received. Exhibitors shall be provided armbands or stickers indicating their dog's running order number for this trial. **Per AKC rules, the move up deadline is 6 pm on Monday, April 28, 2008.** Absolutely no move ups for Saturday will be allowed after this time and date. Move ups for Sunday must be given to the Trial Secretary, at the show site, in writing within 15 minutes of the last dog completing the course.

Other Events at the Fairgrounds

On Saturday, Mensona KC is holding a B-OB Conformation Match. Rings for these events will be on the same large grass area as the agility rings. There will be a horse show on the grounds. Please respect their areas.

Sonoma County Fairgrounds

Directions:

Take highway 101 to Santa Rosa. Exit onto highway 12 eastbound towards Sonoma. Exit highway 12 at the South E Street/Downtown exit. Upon reaching the surface street, Bennett Valley Road, you will come to a stoplight and just in front of you on your right will be the Sonoma County Fairgrounds.

If you are coming by highway 12 westbound, take the Downtown exit, and turn left at the stop light. This will lead you to the entrance to the Sonoma County Fair.

The rings will be outdoors on grass and measure 100' x 100'. Bring cover for sun and rain. Food and beverages will be available for purchase on site.

Parking will be available inside the fairgrounds in the lot on the North East side of the fairgrounds. This is the lot visible from the corner of Bennett Valley Road and Brookwood Avenue.

Overnight Parking

Overnight vehicles may park along the grass; some may park on the grass near the rings – unless it rains the week before the event. In case of rain be prepared to park along the curb and run extension cords to the power pedestals. Enter through the front gate off Bennett Valley Road.

Judging Schedule

Novice and Excellent B&A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Walk through: will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Novice and Open – all heights will walk the course together prior to their class being judged. The Excellent class may be split by height at the discretion of the judge and show committee.

Judging Schedule

Judging will begin each day at 8:00 am. Check in will begin at 7:00 am. All dogs jumping lower than 24" must either: be measured or present a height card at check-in, or have sent copy of the height card to the Trial Secretary with entry for this show. Measurement of dogs without height cards will be at approximately 7:30 am each day and in between classes as time allows.
