Prizes and Awards

Rosettes 1st – 4th place in each jump height class to dogs with qualifying scores. Green ribbons will be awarded to all dogs with qualifying scores. Rosettes will be awarded to Excellent B dogs who qualify in Standard and JWW on the same day. Special MACH rosettes will be offered to all dogs earning the MACH title at this show.

Judging Schedule

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Check in will begin at 6:30 am on Saturday and Sunday. Armbands may be picked up at the score table each morning.

Judging will begin on

Saturday and Sunday at 7:30 am.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:00 am. Open and Novice, all heights will walk the course together prior to their class being judged.

Excellent Standard and JWW will be split into four groups as follows:

4/8/12, 16, 20, 24/26

Excellent FAST will be split in two groups as follows: 4/8/12/16 and 20/24/26.

Kera Holm will judge all Std Classes & Novice FAST

Terry Culley will judge all JWW Classes & Excellent & Open FAST

Sunday:

Kera Holm will judge all JWW Classes & Excellent & Open FAST

Dogs will be judged from the lowest armband number in each class to the highest armband number in each class.

Saturday—Excellent, Open, Novice JWW followed by Excellent FAST, Open FAST

Sunday—Excellent FAST, Open FAST followed by Excellent, Open, Novice JWW

Sunday—4, 8, 12, 16, 20, 24, 26

All dogs, regardless of jump height must either: present a height card at check, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

Measurement of dogs without height cards will take place near the score table at approximately 7:00 am on Saturday and Sunday and between classes when time allows. Judge Kera Holm will measure dogs for cards.

Trial Site and Accommodations**Dixon May Fairgrounds**

The rings will be outdoors on grass and measure 100' x 120'. Bring cover for sun and rain. Dannie's Catering will be onsite selling breakfast and lunch each day. The area on the North lawn bordering Dixon Blvd to Vacaville Way, including the first 6 campsites on Vacaville Way is reserved for the show committee. Anyone other than awards, trial secretary and hospitality who sets up or attempts to camp in this area will be moved. Please allow the show committee to stake the rings and walkways between the rings before setting up your canopies and campsites. No parking is allowed on Dixon Blvd.

Class Information, Jump Heights, Scoring

Classes offered: Regular Titling: Novice A & B, Open, Excellent A & B for Standard, JWW and FAST. Preferred: Novice, Open, Excellent A & B for Standard, JWW and FAST. Owners are responsible for entering the proper class and height. Complete rules can be found on the AKC website at www.akc.org. For a copy of the rule book write to: American Kennel Club, 5580 Centerview Dr., Raleigh, NC 27606-3390. To place a credit card order by telephone call: 919-233-9767 voice and 919-816-3627 fax. Minimum order is \$10. Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walkthrough is restricted to handlers entered in that class. A warm-up jump will be provided for each ring.

Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Monday preceding the event. Day to day move ups are allowed providing the Trial Secretary is notified at the show site, in writing, within 15 minutes of the last dog completing the course.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. 50% refund in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.
