Awards

Rosettes and a dog toy will be awarded to 1st place in each jump height class to dogs earning a qualifying score. Flat ribbons will be awarded 2nd—4th place in each jump height class to dogs earning a qualifying score. Green ribbons will be awarded to all dogs earning a qualifying score. Double Q rosettes will be awarded to Excellent B dogs who qualify in Standard and JWW on the same day.

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Keep your eyes and ears open during the trial for any changes in judging with regards to height order.

Check in will begin at 7:00 am on Saturday and Sunday. Armbands may be picked up at the score table each morning.

Judging will begin on Saturday and Sunday at 8:00 am.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Open and Novice, all heights will walk the course together prior to their class being judged. Excellent Standard and JWW will be split into four groups as follows:

4/8/12, 16, 20, 24/26

Excellent FAST will not be split .

Height Cards

All dogs, regardless of jump height must either: present a height card at check, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

Tammy Domico and Kathie Leggett will measure dogs without height cards at approximately 7:30 am on Saturday and Sunday and between classes when time allows. Measurement will take place near the score table.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in that class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Move-Up Regulations

Dogs may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than noon on the Monday preceding the event. Sunday move ups will be allowed provided that the request is received in writing by the Trial Secretary, at the show site, no later than 15 minutes after the last dog has crossed the finish line on Saturday.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

50% Refund for bitches in season after the closing date and up to Friday before the event.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly

engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

No smoking in buildings or arena.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.
