Prizes and Awards

Ribbons will be awarded 1st through 4th place in each jump height class to dogs with qualifying scores. Green Ribbons will be awarded to all dogs with qualifying scores. Rosettes will be awarded to Excellent B dogs earning a Double Q. Rosettes will be awarded to dogs completing a title and a special MACH rosette awarded to any dog earning the MACH title.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Check in will begin each morning at 7:30 am. Armbands may be picked up at the score table each day.

Judging will begin each day at 8:30 am.

Walk through will begin as soon as the Judges have approved the courses. This will be at approximately 7:30 am each day. Open, Novice, and all FAST classes—all heights will walk the course together prior to their class being judged. Excellent Standard and JWW will be split into two groups as follows:

Group 1: 4/8/12/16

Group 2: 20/24/26

The order will be walk run, walk run, etc.

Unless you have a conflict, i.e. showing in another ring or working, you **MUST** walk with your group.

All dogs, regardless of jump height, must either: present a height card at check, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

AKC Representative Carrie DeYoung and Tammy Domico will measure dogs without height cards. Measurement will take place near the score table for 10 minutes at the top of each hour beginning at approximately 8:00 am.

Preferred will run BEFORE regular in Standard and JWW. Preferred FAST will run in order according to time allowed then height.

Special Attraction

After judging is complete on Saturday you will have an opportunity to test the proposed new AKC Agility class. The class is similar to USDAA Steeple chase in that the fastest dog sets the time. All other dogs place below the fastest dog. Two contact obstacles will be used, A-Frame and Teeter.

Additional details regarding the class will be emailed the week before the event. Anyone wishing to enter the test class may do so at the show. Registration for the class will begin at 10 am on Friday and continue until the limit of 100 runs is reached. Entry fee is \$5 per dog. Each dog may enter one time only.

No food or toys will be allowed in the ring.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP / PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. 50% refund for bitches in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarians' recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. The State of California requires Rabies vaccine.
