Awards

Flat ribbons will be awarded 1st – 4th place in each jump height class to dogs earning a qualifying score. Prizes will be awarded to 1st place in each jump height class to dogs earning a qualifying score. Green ribbons will be awarded to all dogs earning a qualifying score. Double Q pins will be awarded to Excellent B dogs who qualify in Standard and JWW on the same day. MACH ribbons and MACH jump bar will be awarded to any dog earning the MACH title.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in that class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Running Order and Schedule

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Check in will begin at 7:00 am. Armbands may be picked up at the score table each morning.

Judging will begin at 8:00 am each day.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Open and Novice, all heights will walk the course together prior to their class being judged.

Excellent Standard and JWW will be split into two groups as follows:

4/8/12/16 and 2024/26

Unless you have a conflict, i.e. showing in another ring or working, you **MUST** walk with your group.

The order will be walk run.

Preferred heights will run before regular heights.

Kylie Bourke will judge all JWW Classes, Excellent & Open FAST.

David Lawniczak will judge all Standard Classes & Novice FAST.

Saturday:

Kylie Bourke will judge all Standard Classes & Novice FAST.

David Lawniczak will judge all JWW Classes, Excellent & Open FAST.

Sunday:

Kylie Bourke will judge all JWW Classes, Excellent & Open FAST.

David Lawniczak will judge all Standard Classes & Novice FAST.

Dogs will be judged from the lowest armband number in each class to the highest armband number in each class.

Height Cards

All dogs, regardless of jump height must either: present a height card at check, send a copy of their height card with entry to this show, or be measured. Dogs that do not have an AKC height card or who have not provided a copy of their height card to the trial secretary must be measured BEFORE their first run of the weekend.

Measurement of dogs without height cards will take place near the score table at approximately 7:30 am each day and between classes when time allows. AKC Representative Barbara Budnar will measure dogs for height cards. If you have any questions come to the score table.

Class Information, Jump Heights, Scoring

Classes offered: Regular Titling: Novice A & B, Open, Excellent & B for Standard, JWW and FAST.

Preferred: Novice, Open, Excellent A & B for Standard, JWW and FAST. Owners are responsible for

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline rules for the listing of registrable breeds that may participate.

Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.

If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

50% refund for bitches in season after the closing date and up to the Friday before the event.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors, while competing must wear proper footwear. Exhibitors will not be allowed to compete in "bare" feet or open toe shoes.

No smoking in buildings or arena.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Failure to follow the instructions of the Show Committee or their Agent will result in a Bench Committee Hearing.

Unsportsmanlike conduct will result in a Bench Committee Hearing.
