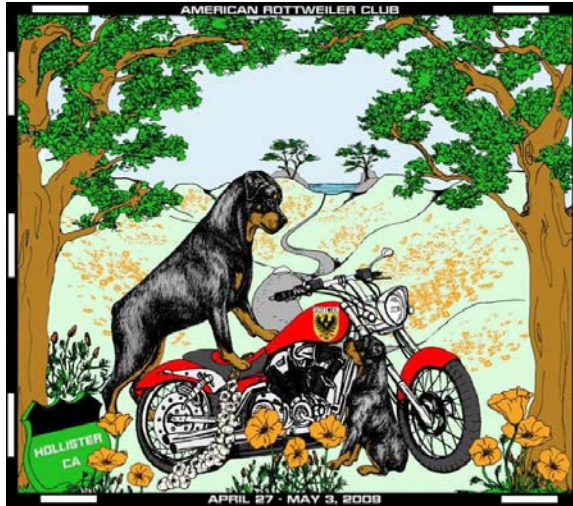

Tuesday—FAST Classes Excellent, Open, Novice followed by JWW Excellent, Open  
Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height.

**Class Information and Obstacles**

**Classes offered:** Regular Titling: Novice A & B, Open, Excellent A & B for Standard, JWW and FAST. Preferred: Novice, Open, Excellent A & B for Standard, JWW and FAST. Owners are responsible for entering the proper class. Complete rules can be found on the AKC website at [www.akc.org](http://www.akc.org). For a copy of the rule book write to: American Kennel Club, 8051 Arco Corporate Dr., Ste 100, Raleigh, NC 27616-3390. To place a credit card order by telephone call: 919-233-9767 voice and 919-816-3627 fax. Minimum order is \$10. Obstacles will conform to the current edition of the AKC Regulations for Agility Trials.

**Course Familiarization/Warm-ups**

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. The walk through is restricted to handlers entered in that class. A warm-up jump will be provided for each ring.

## Move-Up Regulations

Dogs entered on Monday may be moved up to a higher class at the request of the owner, as a result of qualifying for an agility title, provided that the request is received in writing by the Trial Secretary, no later than 6 pm on the Wednesday preceding the event. Tuesday move ups will be allowed provided that the request is received in writing by the Trial Secretary, at the show site, no later than 15 minutes after the last dog has crossed the finish line on Monday.

## Notice to Exhibitors

- This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP / PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline rules for the listing of registrable breeds that may participate.
- Running order will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible.
- If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.
- Returned checks do not constitute a valid entry. No conditional or phone entries will be accepted. Entry forms will not be accepted without fees or signature. Entries not on official AKC forms or photocopies of entry forms without the Agreement and Rules on the reverse side are not acceptable. Changes, additions or corrections to entry forms must be received in writing prior to closing of entries.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- EXHIBITORS ARE RESPONSIBLE FOR COMPLETE, ACCURATE, AND LEGIBLE INFORMATION ON THEIR ENTRY FORMS; ILLEGIBLE OR INCOMPLETE ENTRIES CANNOT BE ENTERED IN THE TRIAL.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and /or children. Any exhibitor whose dogs and /or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund on any fees paid will be made.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run.
- Please be courteous and pick up after your dog.
- Exhibitors, while competing must wear proper footwear. Exhibitors will not be allowed to compete in "bare" feet or open toe shoes.
- Dogs under six months of age are prohibited at AKC Agility Trials
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations. Rabies vaccine is required in the State of California.
- 50% Refund for Bitches in Season after closing date and up to 5 days before the first event. No refund given after that time.

## Trial Site and Accommodations

The fairgrounds are located at Bolado Park, Highway 25, eight miles south of Hollister, just beyond Tres Pinos.

### Directions

#### From Hwy 101 going north:

Take Hwy 156 (San Juan Bautista) exit and bear right. Stay on this road past San Juan Bautista (SJB/Hollister Rd.). Turn right at the signal onto Union Rd. Continue on Union, winding around the outskirts of Hollister, to the 4-way stop at Hwy 25/Airline Hwy. Turn right and continue past Tres Pinos to Bolado Park—San Benito County Fairgrounds.

#### From Hwy 101 going south:

Take Hwy 25 (Hollister/Pinnacles) exit and go back over the freeway. Approaching Hollister, turn left on Wright Rd. (shortly before 156/25 intersection), which turns into McCloskey. At the end of McCloskey, turn right onto Fairview. Continue to the 4-way stop and turn left on Hwy 25/Airline Hwy. Continue past Tres Pinos to Bolado Park.

#### From Hwy 5:

Take Hwy 152 West (Pacheco Pass) to Hwy 156 (after Casa de Fruta). Follow Hwy 156 to the signal at Fairview Rd. Turn left and continue to the 4-way stop; turn left on Hwy 25/Airline Hwy and continue past Tres Pinos to Bolado Park.

#### From San Benito Fairgrounds to Oakhill Ranch:

Start at 8398 Airline Hwy, Tres Pinos / Fairgrounds going South toward Murphy Rd. Continue approximately 8 miles. Turn right on Dirt Road which is Old Airline Hwy. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
