In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim or loss or injury which may be alleged to have been caused directly or indirectly to any person or thing the at of this dog while in or about the event premises or grounds or near nay entrance thereto, and I 9we0 personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

**INSTRUCTIONS**

Handlers may opt to enter in a higher height division for all *Regular* titling classes and the FAST titling classes, but not in a division lower than their proper height division.

**Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height higher or lower than their proper height division.**

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. The Judge's measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.
