- Dogs may be entered multiple times in the same class, but a maximum of 3 runs for any one dog

**Exhibitor Rules:**

- Toys & clickers are allowed in the ring
- Food is NOT allowed in the ring
- Maximum course time will be strictly enforced.
- No harsh verbal or physical corrections allowed
- Excusal for dog fouling the ring

**General Info:**

- The Standard Course will set. You may run the numberd pattern or your own pattern.
- No scoring or ribbons/prizes offered.
- Match will begin 30 minutes following the conclusion of the Sanction A Match.
- Entry fees will not be refunded if the dog is absent, disqualified, excused, or barred from competition by action of the trial committee. If, because of riots, civil disturbances, or other acts beyond the control of the management it is impossible to open or complete the match, no refund of entry fees will be made.

In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or leaser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.
