Class Information, Height Division, Obstacles, Scoring

Ring Size and Surface

The trial will be held under covered pavilion on grass. Ring size will be 100 x 100.

Course Familiarization/Warm-ups

Handlers in all classes are permitted to walk the course, without a dog, prior to the start of a class. Only handlers entered in a class are allowed to walk the course during familiarization. No coaches/instructors are allowed unless they are entered in the class. A warm up area, consisting of a regulation agility jump, shall be provided for all exhibitors.

Height Cards and Measuring:

All dogs, regardless of jump height, who are under two years of age and do not have a temporary height card or are over two years of age and do not have a permanent height card must be measured prior to their first run of the weekend. It is the exhibitor's responsibility to ensure their dog is measured before their first run. Measurement of dogs will take place near the score table each day for 10 minutes at the top of each hour. If you need to be measured "raise the flag". Cindy Macklin or Tammy Domico will measure.

Judging Schedule

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

Check in will begin at 7:00 am each day. Armbands may be picked up at the score table each morning.

Judging will begin each day at 8:00 am.

Walk through will begin as soon as the Judge has approved the course. This will be at approximately 7:30 am. Open, Novice and all FAST classes—all heights will walk the course together prior to their class being judged.

Walkthrough for Excellent Standard and JWW will be split into four groups as follows:

Jump heights 26, 24, 4, 8

Group 2:

Jump height 20

Group 3:

Jump height 16

Group 4:

Jump height 12

The order will be walk run, walk run, etc.

Unless you have a conflict, i.e. showing in another ring or working, you **MUST** walk with your group.

Dogs will be judged from the lowest armband number in each class to the highest armband number in each class.

Conflicts

We understand there are multiple breed specialty shows on Friday and Saturday and all breed conformation, obedience and rally on Sunday and Monday. We also understand that other rings may be quite a distance from the agility rings. Every effort will be made to accommodate conflicts, however, it is the exhibitor's responsibility to check in, mark their dogs as a conflict if necessary and walk courses when assigned. We can reset bars for exhibitors "caught" in other rings BUT we cannot hold any course waiting for conflicts.

Excerpt from the AKC Agility Judge newsletter dated June 2008. As discussed in the *Regulations for Agility Trials* and the *AKC Agility Judges Guidelines*, conflicts pertain to conflicts occurring at the agility trial, not to conflicts of a personal nature that may cause the exhibitor to arrive late or need to leave early from a trial.

Examples of conflicts that should be accommodated: handler running multiple dogs, handler or dog that is scheduled to be in two different rings at the same time, and when a handler or dog is entered in multiple venues held on the same show grounds, (exhibitors volunteering in other rings).

Examples of issues that are **NOT** conflicts include but are not limited to: arriving at the trial site late and missing either the run or walk through, having a personal appointment or duty to attend to, or any other scheduling conflict issue of a personal nature. This is also true for exhibitors who wish to move themselves up in the running order so that they may leave the trial early or down in the running order so that they may arrive late. Handlers may not be moved up or down in the running order due to these types of personal issues.

Handlers who earn qualifying scores while violating this policy will be excused and lose those legs.

Exhibitors may NOT move their own dogs at the gate. Moves at the gate can only be made one of the following persons:

If you have a legitimate conflict speak with one of these people and they will move your dog.

The following special awards have been offered during the weekend.

Irish Water Spaniel Club of America

Sunday: Highest Scoring Irish Water Spaniel will receive Fused glass plate with Irish Water Spaniel Motif created Glass Art Created by Cat's Eye Glass Art.

Portuguese Water Dog Club

Saturday and Sunday

Flat ribbons will be awarded 1st—4th place in each jump height class to dogs earning a qualifying score. Green ribbons will be awarded to all dogs earning a qualifying score. Rosettes will be awarded to dogs finishing a title. While supply lasts Rosettes will be awarded to Ex B Std/JWW dogs earning a Double Q. Once Rosettes are gone QQ pins will be offered. QQQ pins will be awarded to Excellent B Std/JWW dogs earning a triple Q. MACH Rosette will be awarded to all dogs earning the MACH title. First Place in each class will receive a voucher valid for \$3 off entry fees at a future Del Valle Dog Club agility trial.

Friday and Monday

Ribbons will be awarded 1st—4th place in each jump height class to dogs with qualifying scores. First Place in each class will receive a voucher valid for \$3 off entry fees at a future NCBCF agility trial. Green Ribbons will be awarded to all dogs with qualifying scores. While supply lasts Rosettes will be awarded to Ex B Std/JWW dogs earning a Double Q. Once Rosettes are gone QQ pins will be offered. QQQ pins will be awarded to Excellent B Std/JWW dogs earning a triple Q. MACH Rosette will be awarded to all dogs earning the MACH title.

High In Trial—Bearded Collies Only—Bearded Collie Tiles will be offered for Standard and JWW and FAST on Friday and Monday.

The Awards Table will be located near the score table. Once the Judge has signed off on the scores the ribbon labels will be printed and placed in the pink clipboard on the Awards Table. There will be a check off sheet on the top of the clipboard indicating which classes have been signed off and labels printed. You may take your ribbon if the label has been printed.

To receive your first place voucher QQ pin or QQQ pin seek out Pam Hetrick or Barbara Sciaroni who will be stationed at the score table. No awards will be mailed.

Notice to Exhibitors

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, Listed in the AKC Canine Partners Program, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

Full refund for bitches in season before the Monday preceding the event. Full refund less 50% for bitches in season between Monday and Friday.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.
