**Awards**

Rosettes and a dog toy valued at \$2-\$5 will be awarded to 1st place in each jump height class to dogs earning a qualifying score. Flat ribbons will be awarded 2nd—4th place in each jump height class to dogs earning a qualifying score. Green ribbons will be awarded to all dogs earning a qualifying score. Double Q rosettes will be awarded to Excellent B dogs who qualify in Standard and JWW on the same day. QQQ Pins will be awarded to Excellent B dogs earning a Triple Q.

**Schedule**

Novice B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. Excellent B/A Standard, JWW and FAST classes will run together by jump heights with division B running before division A. The preferred classes will run intermingled with the regular classes by height. Each class will be briefed separately. Lunch breaks will be at the Judge's discretion. A warm-up area, consisting of a regulation agility jump will be provided for all exhibitors.

**Check in** will begin

Friday at noon on Friday

Saturday at 7:00 am

Sunday at 6:30 am. Armbands may be picked up at the score table each day.

**Judging will begin**

Friday: 1:00 pm

Saturday: 8:00 am

Sunday: 7:30 am

**Walk through** will begin as soon as the Judge has approved the course. This will be at approximately:

12:30 pm on Friday

7:30 am on Saturday

7:00 am on Sunday.

Open and Novice Standard and JWW and all FAST Classes—all heights will walk the course together prior to their class being judged. Excellent Standard and JWW will be split. The order will be walk run, walk run, etc.

Unless you have a conflict, i.e. showing in another ring or working, you **MUST** walk with your group.

**Dogs will be judged** from the lowest armband number in each class to the highest armband number in each class.

**Run Order—Friday**

Excellent handlers are divided into two groups as follows:

Group 1: 8, 12, 16 jump height order—walk through will be split 8/12 and 16

Group 2: 20, 24, 26 jump height order—walk through will be split 20 and 24/26

Rings will run in “lock-step”. Groups will rotate to the next course only after each dog in their group has attempted the course or is marked ABS.

**First Rotation:**

Standard Ring: Group 1 = 8, 12, 16 dogs

The 16” handlers work for 12” / 8” then switch.

JWW Ring: Group 2 = 20, 24, 26

The 24”/ 26” handlers work for 20” then switch.

**Second Rotation:**

Standard Ring: Group 2 = 20, 24, 26

The 24”/ 26” handlers work for 20” then switch.

JWW Ring: Group 1 = 8, 12, 16

The 16” handlers work for 12” / 8” then switch.

JWW Ring: Novice, Open, Excellent FAST classes. All FAST classes will run Small to Tall.

### **Height Cards and Measuring**

All dogs, regardless of jump height, who are under two years of age and do not have a temporary height card or are over two years of age and do not have a permanent height card must be measured prior to their first run of the weekend. It is the exhibitor's responsibility to ensure their dog is measured before their first run. Measurement of dogs will take place near the score table. On Saturday and Sunday Cindy Macklin will measure dogs for cards.

**Set Ups** All crating space will be in the covered sheep barn adjacent to the Sports Arena Lawn. You may begin setting up your crates at 11 am on Friday.

### **Food and beverages**

A variety of vendors will have food for purchase.

**Notice to Exhibitors**

This event is open to all AKC registered dogs 15 months of age or older that are registered with the American Kennel Club or that have obtained AKC ILP/PAL numbers, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury or illness which may affect the dog's physical or mental performance. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Running orders will be determined by random draw. Handlers with more than one dog in a class will have those dogs separated as much as possible. If a dog and/or handler are dismissed, regardless of the reason, there will be NO refund of entry fees.

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused or barred from competition by action of the Trial Committee.

50% Refund for bitches in season after the closing date and up to Friday before the event.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms. Illegible or incomplete entries cannot be entered in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances ore repeatedly

engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run.

Please be courteous and pick up after your dog.

Exhibitors while competing must wear proper, toe enclosed, footwear.

No smoking in buildings or arena.

Dogs under six months of age are prohibited at AKC Agility Trials

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations. Rabies vaccine is required in the State of California.
